SHOW CAUSE NOTICE FOR NON SUBMISSION OF PLACEMENT RECORDS

1. The submission of placement record was made mandatory by the Directorate vide D.G. Shipping Circular No.01 of 2007 dated 1st March, 2007 and D.G. Shipping Circular No.1 of 2008, dated 24th March 2008 for all the Pre-Sea Courses. Further, the submission of placement record through online mode for all pre-sea courses, completed on or after 01.01.2011 was made mandatory vide Training Circular 03 of 2011 dated 22.03.2011. The same was again emphasized and Institute were advised to submit the placement records vide DGS letter No.TR/MISC/9(9)/2014/284 dated 3.6.2014. However, on review of data submitted by the Institutes, It has been noticed that most of the MTIs approved for conducting Pre-sea courses have not submitted placement record online in e-samudra module. List of such MTIs is attached as Annexure A. The non-submission of such placement record amounts to violation of DG Shipping Circular No. 1 of 2008 dated 24/03/2008, Training Circular No.03 of 2011 dated 22.03.2011 and DGS guidelines issued vide No.TR/MISC/9(9)/2014/284 dated 3.06.2014, in addition to the violation of conditions of approval granted and various provisions laid down by DGS Order 01 of 2003 and 2 of 2007. Such violations amount to major non-conformity in terms of DGS order No.1 of 2003 and 2 of 2007.

2. In view of above major non-conformity, your institute is called upon to show cause as to why the suitable disciplinary action for non-conformity as per Part V of DGS Order No. 02 of 2007 should not be initiated against the Institute.

3. This show cause notice is issued with the approval of the Director General of Shipping and ex-officio Additional Secretary to the Govt. of India, in exercise of powers conferred under Rule 75 of the Merchant Shipping (Standards of Training, Certification & Watch-keeping for Seafarers) Rules, 2014, notified under sec 78, 87, 88, 98, 456, 457 & 458 of MS Act, 1958.
