

Whereas, M/s Auburn Shipmanagement Pvt. 3.3 The submitted original Bank Guarantee in respect of M/s Auburn Shipmanagement Pvt. Ltd is being withheld with this office and shall only be returned on submission of requisite documents to this office as per the checklist for the same.
