**Sub: Amendment to Shipping Development Circular 01 of 2013.**

WHEREAS by Shipping Development Circular 1 of 2013 (SD-9/Chart(82)/97-V dated 18.01.2013), the Director General of Shipping in pursuance of the powers conferred on him in respect of the provisions of Section 406 & 407 of the Merchant Shipping Act, (hereinafter called as Act) read with Ministry of Shipping S.O. No. 3144 dated 17<sup>th</sup> December 1960, had issued the guidelines prescribing out the terms and conditions for considering the request for grant of licence to foreign flag ships under section 406 & 407 of the said Act, laying down the norms for engaging Indian crew and trainees on board these ships engaged in shipping and related activities in the Indian coastal waters. as enumerated in the said circular.

2. WHEREAS a need has been felt to review the aforesaid circular keeping in view the difficulties, particularly availability of accommodation on board the ships.

3. NOW THEREFORE, the Director General of Shipping in pursuance of the powers conferred on him in respect of the provisions of Section 406 & 407 of the said Act, read with Ministry of Shipping S.O. No. 3144 dated 17<sup>th</sup> December 1960, makes the following amendment to the said SD Circular 01 of 2013 :

3.1.1 Paragraph 5(d) of the said circular stands amended as follows:

"In both the cases at para (a) and (b) above, 15% of the Indian crew so engaged shall be trainee cadets/officers distributed equally (to the extent possible) between the navigational and engineering sides, respectively."

4. The above amendment to the said circular will come into force from the date of issue of this circular.

5. This issues with the approval of the Director General of Shipping & ex-officio Additional Secretary to the Government of India.
