- Test Certificate copies duly endorsed by the RO's Representative for all the componets of the DCP and Fixed Foam Fire Fighting installations [e.g. Pressure Vessels, Valves, Pipe Lines, various equipments, Monitor etc.]

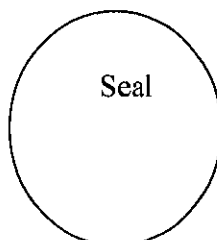
