DGS approved Maritime Training institutes conducting GME course

Subject : Training Circular No.5 of 2012 -admissions of candidates holding degree of Mechanical and Automation Engineering, in GME Course - reg.

Sir,

I am directed to state that the Directorate General of Shipping, Govt. of India, Mumbai, has approved, vide its Training Circular No.5 of 2012 dated 07.09.2012 [File No.TR/ENG/EXAM/17(2)/2010], the Degree of Mechanical and Automation Engineering from a recognized University, as one of the qualifying educational qualification, for the eligibility for an admission in the one year pre-sea training course for Mechanical Graduates [GME], subject to the condition that such candidates have to appear for the 'Heat-Engine' written paper of Marine Engineering Officers [MEO] Class IV Part 'A' Certificate of Competency Exam and the 'Thermodynamics and Heat Transmission' written paper of Marine Engineering Officers [MEO] Class II Part 'A' Certificate of Competency Exam. Para 2 of the said Circular further states that the DGS approved Maritime Training Institutes should bring these conditions to the notice of the candidates, before enrolling them for the GME course, and also that, this condition shall be reflected in the passing out certificates issued to such candidates.

2. However, it has come to the notice of the Directorate General of Shipping, Govt of India that such candidates are not being made aware about the said conditions, as stipulated in the above mentioned Circular, by the DGS approved maritime training institutes concerned, before giving an admission to such candidates.

3. Therefore, all the DGS approved maritime training institutes conducting the GME course are again directed, to strictly comply with the para no. 2 of the said Training Circular No.5 of 2012 dated 07.09.2012 [File No.TR/ENG/EXAM/17(2)/2010]. In case of non-compliance thereof, further necessary action will be taken.
